ENDOWMENT PARTICIPANT NEWS

This statement represents the activity for your account for the year 2010 . If you recognize a discrepancy, please notify the ELCA Foundation promptly. The annual distribution amount (paid quarterly) for 2009 was \$48.091 per unit. The annual distribution amount for 2010 will be \$44.593. This represents 4.5% and 4.25% of the average market value of the five previous year ends, respectively. Investment results through March indicate a return of 4.40%, compared to the fund's benchmark of 4.42%. For the year 2009 the return was 29.14%, 29.16% for the benchmark. All figures are gross of investment management fees. Our quarterly performance report will be mailed in early May. The report is also updated on our website @ www.elca.org/endowmentinvesting Accounting for the Endowment Fund Pooled Trust is on a market value basis. The fund's management fee is 1%, charged in monthly increments.

NOTES:

Reinvestment of income distributions results in additional units. Income distributed in excess of the standard distribution rate will result in a withdrawal of units.
