**MOTION:**

Dave Rupnik proposed for Trinity Lutheran Church to move forward with a letter of intent, to enter into a long-term tenant agreement, for not less than 10 years, on our 1959 property with the Lower Susquehanna Synod.

Discussion ensued. Motion passed.

**MOTION:**

A&P moves to approve the job description for a part-time (10-15 hours per week) sexton. Jon Andrews seconded.

Discussion ensued. Motion passed.

**MOTION:**

A&P moves to approve the job description for a part-time (10 hours per week) Director of Technology. Dave Rupnik seconded.

Discussion ensued. Motion passed.

**MOTION:**

A&P moves to approve the job description for the Director of Administration and Property including additional compensation for the expanded position. Aggie Clark seconded.

Discussion ensued. Motion passed.

**MOTION:**

Finance moves to approve funding the positions of Part-time sexton and Director of Technology for 2020. Jon Andrews seconded

Discussion ensued. Motion passed.

**MOTION:**

Finance moves to authorize expenditure from MIRA not to exceed \$6,500 to Houck for repair for the chimney. Jon Andrews seconded.

Discussion ensued. Motion passed.

**MOTION:**

Finance moves to spend no more than \$28,000 from MIRA for the purchase and installation of air purification units by Thermotech. Dave Rupnik seconded.

Discussion ensued. Motion passed.

The chair reported that funds for pre-school payroll were included in the PPP loan application to maintain Trinity's overall payroll. The pre-school has not yet been reimbursed for the payroll amount expended and has a current deficit of \$8,466.

**MOTION:** Finance moves to immediately transfer up to \$29,000 PPP Loan funds to Trinity's Preschool. Mike Akers seconded.

Discussion ensued. Motion passed.

Informational items:

1. Council President is requesting all committee chairs to compile a list of their committee members along with the amount of time each member has served on that committee.
2. Re-visit what our constitution says about term limits and discuss how we implement this policy going forward.

Mike Akers moved to adjourn.
